On Thursday June 29th, 2023, The Central Co-operative Credit Union Ltd held its 15th Annual General Meeting (AGM) with the theme *Riding into the Future with Financial Security and Stability as we Embrace Change Together*. As CCCUL celebrates 15 years as a member-owned, member-governed, member-managed financial Co-operative serving 16,027 members all over Dominica and overseas; the Board of Directors and Management saw it fit to highlight the society's success in what was deemed a challenging financial year at the institution.

Corporate Social Responsibility (CSR), digital presence, improved members experience, improved capital position, asset growth, 7% dividend, and membership growth while successfully implementing the Invest MYCCCUL Capital Accumulation Strategy are key achievements of the financial year 2022.
